## **CAR SEAT SAFETY**

Auto Accidents are a fact of life, especially in a bustling area like Pinellas County. But there is plenty you can do to reduce the chance your child will be hurt in a wreck, starting by using a quality car seat, and using it correctly.

Here are eight things to think about as you work to ensure your child's safety in your car or truck.

1. **Don't use a previously owned car seat unless you know its history.** Buying a car seat at a yard sale is taking a chance on your child's safety, because you don't know if the seat is past its expiration date (typically around a 6-year timeframe), or whether it's been damaged.

2. **Do your homework on when a car seat or booster seat is required.** As examples of applicable laws, children 3 and under are required to be in a car seat, while kids 5 and under are required to be in an "appropriate restraint mechanism." Then, for children up to age 9, rules depend on a child's height and

3. Having children under 13 in the back seat is the safest place for them to be. Front-passenger airbags simply aren't designed for kids.

4. It's important that your child is in a rear-facing car seat until age 2, or until the car seat manufacturer's requirements allow for facing the child forward. Studies have shown that infants can have more serious injuries if facing forward, where they could suffer injuries to their neck and head in an impact.

5. Think about items in the car that could cause injury in an accident. It isn't uncommon for a child to be hurt by something flying through the car in an accident. This could be anything from a bowling ball to a screw-driver to a water bottle. Either secure such items or don't keep them in the vehicle. Also, don't attach toys to car seats that could cause an injury.

6. While driving, resist the temptation to be constantly looking at your children and reaching back to sooth them. Reducing distractions makes you a safer driver. Resist reaching back to a child, texting or fiddling with the radio.

6. Have a second key available in case you lock the keys in your car. Think about using an item such as a small key box that can be attached somewhere on the car.

7. There are free classes available to help you understand the law and help make sure you are being safe. Sunstar Paramedics offers regular classes on child passenger safety (CPS). For information and to find out when the next classes are, go to <u>www.AllKids.org/CarSeatClass</u>.

### EMERGENCY DISPATCH TRAINING GOES NATIONAL

The Sunstar Communication's Center Training Team, including Coordinator Ron Shiner and Training Officer Eric Fayad, was featured in the March/ April publication of *The Journal of Emergency Medical Dispatch*. The article discussed their presentation at the 2012 Navigator Conference in Baltimore, MD, an annual gathering that fosters an educational venue pertinent for those working in police, fire, and medical emergency communications.. Their presentation topic, "When They Just Do Not Get it", was a hit at the conference. The article describes the approach of the communications training team when it comes to attitude. "We will go to great lengths for someone with a great



attitude," Ron shiner said. Eric discussed catching red flags before they train students or early in the training to "nip the problem in the bud." The team is presenting again at this year's Navigator Conference, being held in Salt Lake City. Their training will include the Dispatcher's role in EMD during radio communications in a large scale or hostile incident. As an example, the Training Team will use the Sunstar Paramedics radio traffic from the January 2011 St. Petersburg police officer shooting to demonstrate the importance of EMD during such critical events.

The Sunstar Communications Center has been an Accredited Center of Excellence (ACE) from the International Academy of Emergency Dispatch (IAED) since 1999. The center's staff exceeds the requirements set forth by the IAED for the ACE centers around the world and maintains scores every month that have placed them in the top 5 internationally for compliance.
